Effective Date 1 January 2017

With effect 1 January 2017, Mediscor will apply the scheme rules applicable to pharmacies and dispensing doctors for COMMED as outlined below.

*Note that Mediscor will only be processing **HIV & Oncology** medicine claims for the **Roots** option as from 1 January 2017. Other benefits to be processed by CareCross.

Processing of medicine for De Luxe, Standard and Shina remain unchanged.
