Effective Date 1 February 2021

Mediscor PBM will continue processing claims for pharmacies and dispensing doctors for United Health Insurance (**Eswatini Providers**) as outlined below.

United Health Insurance will be changing Mediscor claiming code effective 1 February 2021 from **MDS0070** and be replaced with **SWZ0003** for all claims.
